1 EXECUTIVE SUMMARY

Community Health Assessments are an essential part of providing quality healthcare and implementing community health programs. This community-wide process identifies the most important factors affecting health in the community in order to develop a plan to build on strengths and work on gaps. Local public health departments are required to complete a community assessment at least every five years and, since the passage of the Affordable Care Act in 2010, nonprofit hospitals are required to complete one every three years. In order to increase collaboration and share resources, the Henry County 2023 Community Health Assessment and the 2024-2026 Community Health Improvement Plan were completed through a partnership between Henry County Public Health, Henry County Health Center, ISU Extension and Outreach, and Healthy Henry County Communities, the county's wellness coalition.

The assessment process included gathering primary data from a community survey and secondary data from a variety of sources from state and national organizations. Several meetings were held to review and analyze the survey results and data, identify common themes, and prioritize those themes. This Community Health Assessment includes an overview of all of the data with detailed survey results in the appendices. This report also highlights the identified priorities with an outline of the strategies that appear in the Community Health Improvement Plan.

The assessment identified eight priorities that needed to be addressed in order to make Henry County a healthier place to live and work:


- Behavioral Health
- Cancer
- Healthy Food Access and Awareness
- Active Living
- Older Adult Health and Aging Issues
- Access to Care
- Economic Concerns
- Heart Disease, Stroke, and High Blood Pressure

Of those eight priorities, the first six are included in the Community Health Improvement Plan which will be used to guide community health activities in Henry County for the next three years. The plan is a collaborative effort led by Henry County Public Health, Healthy Henry County Communities, Henry County Health Center, and ISU Extension and Outreach but will include many other community partners necessary to the success of the plan. 2 COMMUNITY DESCRIPTION

Henry County, a rural county with a 2022 population estimate of 20,196, is located in southeast Iowa. The county seat is Mt. Pleasant and other incorporated towns located inside of Henry County include Hillsboro, New London, Olds, Rome, Salem, Wayland, Westwood, and Winfield. Henry County covers 434 square miles with 47.2 people per square mile.

DEMOGRAPHICS

52.2% of the population is male and 47.8% of the population is female. Twenty percent of the population is 65 years or older which is higher than Iowa's overall rate of 18.3%. There is a lower percentage of young people living in Henry County (20.5%) compared to Iowa (22.6%). Henry County is 92.1% White, 3.1% Black or African American, 0.5% American Indian and Alaska Native, 2.4% Asian, and 1.7% two or more races. In addition, 5.6% of the population of Henry County is estimated to be Hispanic or Latino. [1]

EDUCATION

Henry County is home to four public school districts: Mt. Pleasant Community School District, New London Community School District, WACO Community School District, and Winfield-Mt. Union Community School District. In addition, there is one private school, Mt. Pleasant Christian School. Southeastern Community College has a satellite location in Mt. Pleasant which offers educational and workforce development opportunities. The education landscape changed in 2023 when lowa Wesleyan University, a private liberal arts university located in Mt. Pleasant, closed their doors after 181 years. 92% of residents over the age of 25 have at least their high school diploma or GED and 21.7% of this group have their bachelor's degree or higher [1].

HOUSEHOLDS AND HOUSING

There are approximately 7,565 households living in Henry County with an average of 2.51 people per household. Approximately 6% of households speak a language other than English at home [1].

There are approximately 8,451 housing units in Henry County and 76% are owner-occupied. The median value of owner-occupied housing is \$126,400. Median housing costs for owners with a mortgage is \$1,139. Median monthly gross rent is \$689 [1]. 81% of households have a broadband internet connection [2].

INCOME

The median household income in Henry County is \$58,767. This is lower than the state median of \$65,429. Twelve percent of all residents and 15% of children under the age of 18 live in households earning less than the federal poverty level [1]. The 2023 federal poverty level for a single adult is \$14,580 and \$30,000 for a family of four [3]. 21% of children live in single-parent households [2].

FOOD SECURITY

The USDA defines food insecurity as a lack of consistent access to enough food for every person in a household to live an active, healthy life. This can be a temporary situation for a family or can last a long time. According to Feeding America, the food insecurity rate in Henry County is 7.7% which translates to 1.580 people. However, the Hunger Vital Sign measurement tool was included in the 2023 Henry County Community Health survey and 28% of respondents were determined to live in a food insecure household, up from 27% in 2020. This means they answered "sometimes true" or "often true" to one or both of these questions –

- Within the past 12 months we worried whether our food would run out before we got money to buy more.
- Within the past 12 months the food we bought just didn't last and we didn't have money to get more.

According to County Health Rankings, 47% of children were eligible for free or reduced price lunch (using 2020-2021 data), up from 43% in the 2020 rankings and greater than the state average of 41%.

HENRY COUNTY HEALTH CENTER

Henry County Health Center, Inc (HCHC) recently became part of Great River Health System through an operating lease agreement. Located in Mt. Pleasant, Iowa, HCHC is a not-for-profit, critical access hospital serving the Henry County area for 102 years. The hospital provides comprehensive inpatient and outpatient services as well as specialist physician clinics. The hospital also operates a nursing home unit, geriatric mental health service, and rural health clinics with primary care physicians and advanced practice providers. 3 COMMUNITY SURVEY

As part of the community health assessment, we conducted a community survey in June 2023. The survey collected demographic information, perspectives on healthcare access, and opinions on the most important health needs of the county. With this survey we looked at more than just basic health needs, but we also asked about social determinants of health which include safe housing, transportation, education, job opportunities, and more. We used the same survey questions as the 2020 survey so the data analysis could compare responses. Respondents could complete the survey online or by filling out a paper copy made available at public locations across the county. The survey was translated into Spanish and outreach activities targeted typically underrepresented groups. Conscious efforts were made to include residents of Henry County who live in small towns and rural areas outside of the county seat of Mt. Pleasant. There was a total of 641 completed surveys returned to Public Health for data analysis, which is over 3% of the population of Henry County.

SUMMARY OF SURVEY FINDINGS (SEE APPENDIX A FOR FULL RESULTS)

Access to health care (68%) remained the most important factor for a healthy community and a good quality of life. Good schools, low crime/safe neighborhoods, good jobs and healthy economy, and quality and affordable housing rounded out the top five responses this year.

The top 5 perceived barriers to health and well-being remained (although in a different order) access to mental health care (68%), low wages (58%), poverty (49%), unaffordable housing (45%), and health insurance coverage (39%). However, when asked about personal barriers to health the top 5 were low wages (38%), access to mental health care (29%), lack of free recreational opportunities (27%), health insurance coverage (25%), and access to specialty care (25%). When looking at responses from households making less than \$20,000 per year, low wages and access to mental health care remained the top answers, but access to healthy food, unaffordable housing, and poverty rounded out the top 5.

Although survey respondents could have been referring to any community in Henry County, when asked about five things our community does well the top responses were locally owned and operated businesses (60%), parks and recreation (48%), trails and sidewalks (39%), quality schools (38%), and reasonable commute (34%). Top five things that our community could improve were affordable and quality housing (47%), affordable and quality childcare (44%), variety of food options (dining and shopping) (41%), good jobs (37%), and transportation options (32%).

When asked personally what is missing or most needed in our community to improve your health, mental health services (49%) remained on the top of the list. Specialty physicians (38%), healthier food (34%), wellness services (31%), and affordable health insurance (28%) rounded out the top five, a change from 2020 when childcare, healthier food, job opportunities, and affordable health insurance were the other top choices in order. When looking at responses from households making less than \$20,000 per year, mental health services was still the top choice, followed by transportation options, wellness services, job opportunities, and affordable housing. One question to highlight asked about the top five health concerns in our community:

The survey also asked about difficulty accessing a variety of services. Specialty doctor (36%) and mental health provider (35%) had the highest number answering difficult or very difficult. On the flip side, public health/immunization services (56%), dentist (55%), and primary care doctor (54%) were easy or very easy to access. All survey results, including open-ended responses and survey respondent demographics, can be found in Appendix A.

Once the survey results were complete, the data was analyzed by Dr. Nicolas Foss, MS. He created the data tables and comparisons found in Appendices A and B. Kelly Carr and Dr. Foss shared the results with Healthy Henry County Communities (HHCC), a community wellness coalition led by Henry County Public Health. Members of this coalition include professionals in the public health, substance abuse prevention and treatment, family support, child abuse prevention, tobacco prevention, disability services, school health and counseling, law enforcement, medical, and mental health services fields, as well as retired community members and government officials. They also reviewed related secondary data specific to Henry County from sources such as the County Health Rankings, Iowa Public Health Tracking Portal, and CDC.

HHCC members discussed the current survey results including potential root causes. They looked at changes from the 2020 survey and identified common themes and concerns from the 2023 results and secondary data. Members also looked at the survey responses broken out by household income less than \$20,000 to see how the results were different. Some of the themes identified were existing health needs that HHCC and Public Health have already been working on with the 2020 Health Improvement Plan and some were newly identified.

Healthy Henry County Communities members then began prioritizing the identified health needs while also discussing which needs fall within the scope of organizations involved and which better align with other local agencies. We ended up with eight priority areas and six of those are specifically targeted in the Health Improvement Plan. HHCC members, Henry County Public Health staff, and Henry County Health Center staff all worked on identifying goals, objectives, and strategies for the next three years to include in the Health Improvement Plan. 4 IDENTIFIED HEALTH PRIORITY AREAS

These priorities are in no specific order.

BEHAVIORAL HEALTH


Rationale: In the community survey, mental health was identified as a top health concern by 81% of respondents. Lack of access to mental health care was identified as a top barrier to health in Henry County by 68% of respondents. Henry County is located in a mental health provider shortage area as defined by the Health Resources and Services Administration.

In 2020 14.6% of adults reported that their mental health was not good for >=14 days during the past 30 days. The estimated prevalence of depression among adults aged 18 years and older was 18.9% [5]. The National Alliance on Mental Illness states that the average delay between onset of mental illness symptoms and treatment is 11 years.

Behavioral health is an umbrella term that includes mental health and wellbeing, along with behavioral health conditions such as substance use disorders.

59% percent of community survey respondents identified substance use as a top health concern in Henry County. Substance use includes alcohol and illegal and/or prescription drugs. Substance use disorders involve misuse of one or more of these substances and may lead to several social, physical, mental, and public health problems.

CANCER

Rationale: Iowa has the 2nd highest incidence rate for cancer in the U.S., (behind Kentucky), and is the only state with an increasing rate of cancer [6]. Henry County has higher rates than the state average of lung cancer, colorectal cancer, and melanoma of the skin [7]. The top 5 most commonly diagnosed cancers in Henry County from 2015-2019 were lung, breast, prostate, colorectal, and melanoma of the skin [4]. Cancer is the leading cause of death under age 75 in Henry County [2].

Several cancer screening tests are considered effective and recommended by expert groups including breast, cervical, colorectal, and lung cancer screening. The estimated prevalence of mammography use among women aged 50-74

years in Henry County is 71.4%. Cervical cancer screening rates among women aged 21-65 is 81.7%. Colorectal cancer screening rates among adults aged 50-75 is 72.5% [5]. HPV vaccination remains low even though 85% of people will get an HPV infection in their lifetime and HPV causes several kinds of cancer, including cervical cancer [8]. In the community survey 33% of respondents identified cancer as a top health concern in Henry County.

Included in Health Improvement Plan? Yes.

HEALTHY FOOD ACCESS & AWARENESS

Rationale: In the community survey, obesity was identified by 62% of respondents and poor nutrition was identified by 30% of respondents as top health concerns in Henry County. When identifying personal barriers to health, 23% selected access to healthy food. 28% of respondents indicated that they are food insecure. In addition, 37% of adults in Henry County are obese, up from 33% in 2022 and 47% of children in Henry County were eligible for free or reduced-price lunch [2].

The availability of healthy, affordable foods contributes to a person's diet and risk of related chronic diseases. People with healthy eating habits live longer and are at lower risk for serious health problems such as heart disease, type 2 diabetes, and obesity. For people with chronic diseases, healthy eating can help manage these conditions and prevent complications.

Included in Health Improvement Plan? Yes.

ACTIVE LIVING

Rationale: In the community survey, obesity was identified by 62% of respondents as a top health concern in Henry County. When identifying personal barriers to health, 27% of respondents selected lack of free recreational opportunities. 24% of adults report no leisure time physical activity [2].

Healthy eating and active living can help people maintain a healthy body weight and decrease the risk of becoming overweight or obese. Regular physical activity can also reduce the risk for many of the serious health issues identified in this assessment such as cancer, heart disease, stroke, high blood pressure, depression, and diabetes.

Included in Health Improvement Plan? Yes.

OLDER ADULT HEALTH AND AGING ISSUES

Rationale: Aging problems (such as arthritis, hearing/vision loss) was 4th in the top health concerns from the community survey with 34% of responses. 35% of the respondents with a household income of less than \$20,000 were aged 65 and older. The share of the population that is 65 and older in Henry County was the fastest growing between 2010 and 2021 with an increase from 16.1% to 19.6% [9].

Older adults are at higher risk for chronic health problems like diabetes, osteoporosis, and Alzheimer's disease. In addition, 1 in 3 older adults fall each year, and falls are a leading cause of injury for this age group. Older adults are also more likely to go to the hospital for some infectious diseases — including pneumonia, which is a leading cause of death for this age group [10].

ACCESS TO CARE

Rationale: Access to health care was identified as one of the most important factors for a healthy community by 68% of respondents in the community survey. 38% identified specialty physicians and 28% identified affordable health insurance as something missing or most needed in our community to improve health. When looking at survey responses with a household income of less than \$20,000, 32% identified dental health as one of the top health concerns and lack of transportation was a barrier for 45%. Henry County is designated as a health care provider shortage area by the Health Resources and Services Administration and a low income population dental provider shortage area.

Included in Health Improvement Plan? Yes.

ECONOMIC CONCERNS

Rationale: According to survey respondents, low wages, poverty, and unaffordable housing were 3 of the 4 top barriers to health in Henry County. When asked about things our community could improve, affordable and quality housing, affordable and quality childcare, good jobs, and transportation options were 4 of the top 5 answers.


Included in Health Improvement Plan? No. Social determinants of health are consistently assessed by Public Health and local healthcare providers. In addition, *our* local Chamber of Commerce and Economic Development Commission are in a strong position to also work on these complex issues. We recognize that these needs are important and do affect the health of our residents.

HEART DISEASE, STROKE, AND HIGH BLOOD PRESSURE

Rationale: Heart disease is the second highest cause of death for people under the age of 75 in Henry County [2]. In the community survey, 27% of respondents chose heart disease and stroke as a top health concern and 22% chose high blood pressure. Death rates of heart disease have been rising since 2016 among residents ages 35-64 years [11].

According to the CDC, risk factors for heart disease and stroke include high blood pressure, high LDL cholesterol, diabetes, smoking and secondhand smoke exposure, obesity, unhealthy diet, and physical inactivity.

Included in Health Improvement Plan? Not specifically, but many of the risk factors will be addressed in the plan.

5 HEALTH IMPROVEMENT PLAN

PRIORITY: BEHAVIORAL HEALTH

Goal 1: Improve Access to Behavioral Health Services

- Expand Behavioral Health Services within HCHC Rural Health Clinics (counselors and APPs)
- Recruit mental health professionals to work in expanded clinic
- Expand Senior Life Solutions (group therapy for seniors) by adding 1 additional group
- Develop a public awareness campaign of expanded HCHC services
- Promote existing transportation services

Goal 2: Improve Awareness of Behavioral Health Services/Resources

- Promote awareness of 988, Your Life Iowa, mobile crisis response, and ADDS treatment programs around the county
- Implement a campaign about how to talk to a loved one about substance use/misuse
- Educate school personnel and parents about Narcan and its use for unintentional overdoses
- Update as needed and distribute local mental health resource guides

Goal 3: Increase Prevention Strategies

- Implement a campaign to remind all ages about the dangers of alcohol, marijuana, and meth
- Educate about the importance of proper pill disposal and promote area drug take-back boxes and drug disposal pouches
- Implement a campaign to educate all ages about how easy it is to misuse opioids

Goal 4: Strengthen Mental Health and Resilience

- Plan and implement quarterly kindness campaigns
- Implement a process to do PHQ and GAD screenings for mothers of newborns during WIC and newborn home visits
- Develop a handout for new moms educating about postpartum depression, supports, and resources
- Develop and integrate one mental health screen and intervene process into a community event or outreach activity
- Provide mental health education in schools regarding stressors, feelings, coping, etc.
- Promote campaigns to reduce stigma and increase support around asking for help

PRIORITY: CANCER

Goal 1: Increase Awareness of Recommended Cancer Screenings

- Promote and support programs that provide free or low-cost recommended screenings to people who are uninsured or underinsured
- Create a flyer listing preventive health screenings by age to hand out during immunization clinics and at community events
- Educate the public about cancer screening recommendations by utilizing agency websites, social media, and waiting rooms
- Work with area primary care providers to ensure preventive health screenings are completed timely

Goal 2: Increase Cancer Prevention Strategies

- Promote and increase tobacco/nicotine cessation
- Educate community members on harms of tobacco and nicotine
- Reduce adult and youth exposure to secondhand smoke
- Implement adolescent reminder mailings to increase the number of kids who initiate and complete the HPV vaccination series
- Encourage providers to strongly recommend the HPV vaccine as a cancer prevention strategy
- Increase public awareness of HPV vaccine recommendations and role in cancer prevention
- Encourage availability of sunscreen at outdoor events

Goal 2: Provide Health Management Education to Older Adults

- Develop a plan to check blood pressures and provide health education at senior apartment sites and other community locations around Henry County
- Develop an annual senior health fair
- Promote financial assistance programs that may free up dollars for health management expenses (Affordable Connectivity Program, energy assistance, low-income housing, food assistance, waiver programs, Medicare preventive health services, etc.)
- Increase the number of community members taught to monitor their blood pressure at home
- Explore being trained in or hosting Better Choices Better Health workshops

- Promote prescription delivery services as an alternative to finding transportation
- Increase number of trained staff members to provide presumptive eligibility for Medicaid
- HCHC Rural Health Clinics to develop a chronic care management program for Medicare recipients
- Increase number of primary care, mental health, and long-term care specialty providers in Henry County

Goal 2: Help Residents Navigate/Remove Barriers for Better Health

- Educate both the public and new referral sources about the CARE LINKS health navigation program
- Increase number of referrals to CARE LINKS from health care professionals
- Promote and update as needed the Henry County Community Resource Guide to support residents in finding available services

IMPLEMENTATION RESOURCES

Henry County Public Health will take the lead in many of the strategies included in the plan, whether directly or through leading and participating in the Healthy Henry County Communities coalition. Staff will utilize and expand existing programs while exploring the implementation of new programs. Staff will form committees as needed within Healthy Henry County Communities to capitalize on community partnerships and resources. Public Health will also use their existing marketing resources including website, social media, waiting room, community events, and email lists.

Henry County Health Center will also be involved in several of the plan strategies. Hospital and health system participants include Administrators, Physicians, Nurse Practitioners, Public Information Staff, Volunteers, and Hospital Board Members. Collaboration between area hospitals of Great River Health and utilization of shared resources will be made available to HCHC. HCHC will also provide in-kind support by providing facilities for coalition and team meetings.

HCHC ER is the worst healthcare option in Southeast lowa. I wish it wasn't, but the reputation of HCHC ER is very well deserved. The nurses don't listen, they are rude, and they still don't let more than one parent into the exam room with children even though every other ER on the planet does.

I do not receive services through HCHC. My family goes to Washington or Iowa City.

I dread making phone calls to Henry County Health. It is rare that you get anything accomplished in a timely manner. If systems truly cared for their patients, one would be able to phone a particular office directly.

I wish our city and county leaders cared this much about our health!

It was great first step to get a childcare center in MP, but the cost is not accessible to most families, the facility can only serve a small number of kids, and doesn't address the lack of after school care in our community. It would be wonderful to have an on-going article in the paper or somewhere so that the community will know more about new things happening in Mt Pleasant and surrounding communities. Farmers markets that amount to anything - needs of immunities that we need up-to-date information on - more opportunities for specialty doctors, pharmacies, etc. More community support for EVERYONE - not just those who can afford it.









Access to Specialty Doctor Henry County Health Needs Assessment - 2020













PRIORITY: MENTAL HEALTH

- Updated and distributed youth and adult mental health resource guides
- Ongoing promotion of National Suicide Lifeline (now 988) and Your Life Iowa hotline including through yard signs, sidewalk signs, flyers, magnets, and media advertising
- Began regular kindness campaigns in partnership with Henry County CPPC
- Promoted and provided funding for Mental Health First Aid trainings

PRIORITY: OBESITY/POOR NUTRITION

- Worked with all food pantries serving Henry County and developed a flyer to promote both awareness and the need for donations
- Helped a new community garden in New London get started
- Promoted local produce suppliers with a webpage HealthyHenryCounty.org/local-produce
- Helped the cities of Wayland and Winfield with successful grant applications to improve their city parks
- Provided 5-2-1-0 and SWITCH education in 3 school districts
- Switched our annual Healthy Halloween Walk to June and rebranded as Stride Into Summer Family Walk to combine physical activity with summer health and safety education

PRIORITY: CANCER

- Joined the lowa Cancer Consortium and push out their cancer prevention messages regularly
- Filled all available slots in the Care For Yourself breast and cervical cancer screening program
- Presented to school districts and area businesses about the dangers of tobacco and nicotine products
- Increased the number of school districts and workplaces that implement comprehensive tobacco and nicotine-free policies
- Increased the completion rate of the HPV vaccine in 13-15 year olds by 10%

 Henry County Health Center entered into an operational lease agreement with Great River Health System July 1, 2021. Benefits of this partnership that have and continue to affect access to care are development/implementation of a shared EHR, work group for the expansion of specialty services, rural health clinic, provider recruitment, and other shared resources.

PRIORITY: INFECTIOUS DISEASE MITIGATION

- Created new website for Public Health including a page dedicated to COVID information that was updated regularly throughout the pandemic and continues to be updated
- Provided timely information to the public during the COVID pandemic using relationships with local media including discounted newspaper ads and a regular weekly radio update
- Utilized social media more often and presented to community groups to keep residents informed
- Provided targeted education to high-risk workplaces, schools, nursing homes, and others about ways to reduce COVID spread, including updates as federal guidance was adjusted
