### HENRY COUNTY HOME VISITOR PROGRAM offers

home visits to moms during the first few weeks following the birth of a new child. Foundation funds help cover nursing services that include a physical assessment of baby and mom, discussion and answers to common concerns and written information on newborn growth and development needs.

FAMILY CONNECTION provides early childhood focused family support and education for Henry County parents and children ages 0-5, who are striving to improve overall health and well-being. HCHC Foundation dollars will be used for the provision of group parenting classes, one-on-one family support and early learning opportunities for children of participants.

INPATIENT SERVICES – Through generous individual and family gifts to the Foundation, a new patient recliner was added to the HCHC Medical-Surgical floor. The electronic lowering/raising feature provides safe and easy reclining options for patients and caregivers.

ASSOCIATES – In an effort to support our valued associates in furthering their educational development and professional expertise, HCHC Foundation has provided tuition and professional certification assistance to eligible HCHC employees.

MAMMOGRAPHY FUND – In 2008, the Foundation's Mammography Fund was created to help supplement Henry County Public Health Department's Care for Yourself (CFY) program. CFY provides eligible women access to free mammograms and cancer screening services. HCHC Foundation and Public Health work together to encourage women to get regular mammograms and reduce the fear associated with how to pay for such testing.

# HCHC partners to offer new procedure

## MAMMOSITE® RADIATION THERAPY FOR BREAST CANCER

Henry County Health Center has a new procedure available for breast cancer patients who need radiation therapy. HCHC General Surgeon Dr. Michelle Tansey offers MammoSite® 5-day Targeted Radiation Therapy for women with breast cancer who meet treatment criteria.

#### MAMMOSITE® TECHNOLOGY

When breast cancer is found early, MammoSite® 5-day Targeted Radiation Therapy can be used following lumpectomy to help keep cancer from coming back. It only takes five days and it targets the radiation right to the area that the cancer is most likely to recur. Since it's so targeted, there is minimal radiation delivered to other healthy tissue.

"Patients who have received this therapy have had extremely favorable results. Patients benefit from this partial breast radiation because it takes less time, five days as opposed to six weeks," explained Dr. Tansey. "This means that when patients at HCHC need radiation therapy, they can shorten the treatment time significantly which also results in less travel time. This shortened time

course is good for patients, and it's good for their families and friends who want to see loved ones get better and get the treatment that they need at much less inconvenience for everyone involved."

#### **HOW IT WORKS**

This shortened form of radiation therapy treatment has been approved by the FDA since 2007 and is convenient and safe.

Two to three weeks after the lumpectomy procedure, Dr. Tansey inserts a small, soft balloon attached to a thin catheter (tube) and places it inside the lumpectomy cavity. This procedure is done in Dr. Tansey's office or an operating room at HCHC. The patient then goes to Mercy Medical Center in Cedar Rapids where the placement is checked by CT scan.

The radiation "seed" is placed within the MammoSite® balloon by a computer-controlled machine. During 10 treatments given over five days, the "seed" is placed in the balloon and therapeutic radiation is delivered to the area surrounding

the lumpectomy cavity. After each treatment, the "seed" is removed, but the balloon catheter remains for the next treatment.

The radiation therapy is inserted by the radiation oncologist at Mercy Medical Center on a Monday, and therapy is given twice a day until Friday. After five days of receiving treatment two times a day, the balloon catheter is removed by the radiation oncologist and the area is closed. This means that conventional radiation that takes six to seven weeks to complete, can be completed in five days. A hospitality room is available for patients at Mercy free of charge for the five days of treatment.
